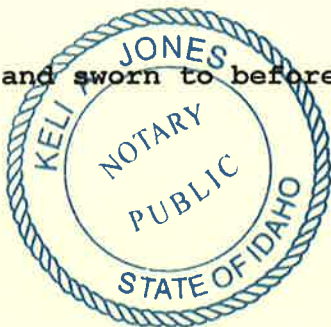


# Declaration of Candidacy


