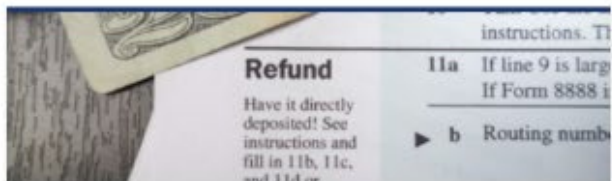

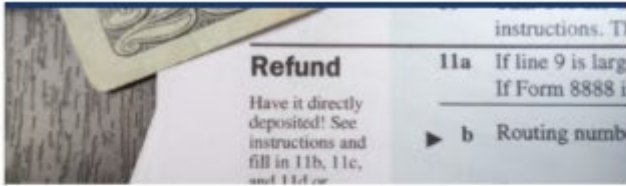

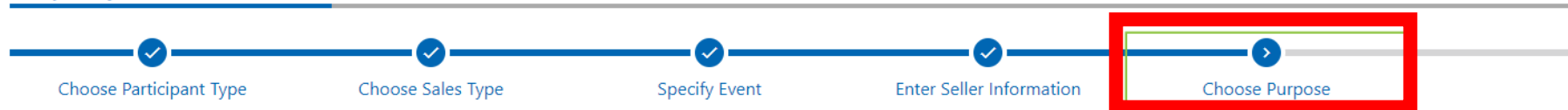

## Temporary Sales and Promoters

### Temporary Sales and Promoters



Choose **I am not making taxable sales** if you are attending an event and not selling products or related services.

Examples include:

- demonstrating a product
- advertising a service
- multi-level marketing (e.g. Scentsy, Avon, Mary Kay)

*NOTE: You will still get a permit that must be displayed during the event.*

Choose **I have a regular permit** if you already have a regular seller's permit. You don't need a temporary permit if you already have a regular tax permit.

For example, if you have a sales tax permit and you're selling the same type of product, you don't need a temporary permit. Just include any extra sales when you file your regular tax form.

Choose **I need a temporary permit** if you are selling products or related services and need a Temporary Seller's Permit.

# IDAHO STATE TAX COMMISSION

## TEMPORARY SELLERS & PROMOTERS REGISTRATION

- **Performance Vendors/Buskers** – Select “I am not making taxable sales” and follow prompts to submit.
- **Vendors without a regular permit** – Select “I need a temporary permit” and follow prompts to submit. Generally, Youth Vendors and any Tier 1, 2, or 3 Vendors that have previously needed an ST-124 tax form.
- **Vendors with a regular permit** – Select “I have a regular permit” and enter your Permit Number. Follow prompts to submit. Generally, any Tier 1, 2, or 3 Vendors that previously filled out the active Idaho Seller’s permit number on ST-124 tax form.
